Abstract

The following dissertation examines the process of negotiations in internal conflict in the Inter Governmental Authority on Development region. It identifies four internal conflicts and comparatively analyses the dynamics of conflict and peace processes. During the examination of the four negotiation processes, the study identifies the parties, the issues and the outcomes of negotiations. It maintains that there is need to begin the study of negotiation processes by examining the issues and parties during conflict in order to determine that parties and issues have been represented. Establishing the relationship between conflict and peace processes also determines if parties have reached a ripe moment. The study makes the conclusion that, the structure of negotiations transforms with the entry of third party attempts at peaceful resolution of conflict. It identifies the significant changes made by mediators to the process. It notes that the structure further broadens to include other external actors into the process. Thus negotiations become multilaterised processes. This distinction is important for the study because during negotiations, communication between parties is important as is the fulfilment of the parties' aims. The study identifies negotiation leaders as individuals whose roles are to represent negotiation parties and facilitate consultations between and among parties within the multilateralised negotiation process. The multiplicity of tasks and issues at stake during negotiations are taken into consideration when negotiation leaders are identified.

To this extent the study identifies and examines the dominant and subordinate negotiation leaders. It makes a case that the type of negotiation leader corresponds to the negotiation issues. It also argues that the roles of negotiation leaders are part of the broad negotiation strategy of the negotiation party. The dissertation concludes that leverage is a crucial factor in determining the roles of negotiation leaders. The dissertation in addition concludes that in protracted internal conflicts and in conflicts which adversaries are armed, principals often take up the role negotiation leader. It identifies Uganda and Sudan as examples. It concludes therefore, there is need to consider the world society approach when managing internal conflict.

Abstract

Somalia, located in the Horn of Africa along the Gulf of Aden and Indian Ocean, is a largely homogenous society. Unlike any of its neighbors, its people share a common language- Somali, religion- Muslim, ethnic origin and a pastoral nomadic tradition. Once one of the strongest countries in the region and having the third largest military force in sub-Saharan Africa during the 1977/78 Ogaden War with Ethiopia, the need for a balance of power among the countries in the region was of a paramount importance. Foreign policy has also always been a major factor in Somalia and for its neighbors for the achievement of peaceful co-existence. Despite this, Somalia had territorial problems with some of its neighbors – and war with Ethiopian over Ogaden, which changed the attitude of not only Ethiopia but also of Kenya towards Somalia.

This thesis examines Siyad Barre's foreign policy and its role in generating the internal Somali conflict. It will explore both the internal and external determinants of Somalia's foreign policy under Barre, and identify the early causes of the Somali conflict and their relationship with its foreign policy. The thesis finally will sensitize policy makers in the region to the importance of creative alternatives to the management of internal conflicts and the formulation and conduct of a peaceful, constructive and cooperative foreign policy in the Horn of Africa sub-region.

Scholars of foreign policy and conflict argue that the contradicting foreign policies of Somalia and Ethiopia have had a great and negative impact on the current internal conflict in Somalia and that in order to prevent further conflict there is a need for an alternative conflict management mechanism. Further the formulation and conduct of a peaceful, constructive and cooperative foreign policy by future Somali governments and others in the Horn of Africa sub-region is essential if Somalia is to have internal peace.

ABSTRACT

The study is based on the premise that a country's constitution is a fundamental pillar upon which the society is structured. The application of an anomalous constitutional paradigm engenders structural conflict in society. The study establishes that the existing Kenya constitution is a fundamental source of structural violence in Kenyan society. Constitutional conflicts are considered to be sub-species of structural conflicts. The erosion of constitutionalism in Kenyan has contributed to the exacerbation of structural violence. The structural sources of constitutional conflicts in Kenyan society are explored through the process and content debates relating to the existing constitution. Ultimately the study establishes that the process and content of constitution-making are inextricably linked and a defective process leads to an anomalous content within the constitution. The study finds that attempts to address constitutional conflicts in Kenya have often been settlement rather than resolution-oriented. The study applies and critically appraises the use of structural violence as a theoretical framework. It is found by the study that structural violence needs to be complemented by other analytical tools of conflict theory such as human needs theory, the role of third parties in conflict and ethnic conflict theory in order to provide a complete framework for the understanding of Kenya's constitutional conflicts. Constitution-making is also eminently a political process and both the Kenyan political landscape and the broader political context of African states needs to be considered to appreciate Kenya's constitutional conflicts. The unique contribution of the study is applying a conflict perspective to provide a deeper insights into Kenya's constitutional debates and thus provide a possibility of eventually resolving the conflicts.
